**Notification of the board meeting was advertised on the Pinnacle Classical Academy website and the front and side doors of the school building were open.

Welcome – Debbie Clary, Chair called the meeting to order at 4PM. There was a brief introduction to Board members as there were visitors present and Senator Clary welcomed Bobby Horton, parent liaison, back to the Board.

Jayson Philbeck - After the reading of the conflict of interest statement. Jayson Philbeck noted that he had a conflict of interest as he works for Alliance Bank and we that bank. He would like to recuse himself from voting as a conflict of interest. Jayson joined Pinnacle's Board in 2016 or 2017 and Pinnacle was already using Alliance at that point.

Adoption of Agenda This is a called session and will be voting on the lowest bidder on the contract as presented on the Holland and Hamrick Bid Sheet. Bobby Horton made the motion and Pauline Cahill Seconded, all approved.

Discussion about the construction costs and alternates occurred. Copies of the bid sheet were reviewed. The Lowest bid is Strickland Construction by 69,000. The Total Proposed Construction Budget is 16,585,709 and the USDA Loan is 15,000,000. Pinnacle is over the original budget 1,585,709 which is about 10% over projected and Pinnacle will get the footprint we need to move forward.

Bobby Horton made the motion to accept the lowest bid of Strickland Construction without the alternates. Dr. Pauline Cahill seconded the motion, Board approved with no opposition.

Jayson Philbeck did not vote



I have attached the architect's bid sheet. Please note we have taken the two lowest bidders and reduced their bids by the alternate items (4) that were bid separate for our consideration. As with our first loan, we have discussed with our USDA representative and will be taking the lowest bid on Phase II. That bid is from Strickland Construction.

We will be voting to accept the lowest bidder on the contract and I will need a motion to that effect. Beyond the low bid contract, we are still working to reduce cost and the occurrence of contingencies that would erode the 5% held for such. (\$752,000)
