Teacher Retention

- 3rd grade teachers and EC teachers received follow up Inclusion Training on October 2nd. This is the approach that we are using in 3rd grade with our students in the EC program. We are training everyone in this approach to ensure student and teacher success.
- Weekly walkthroughs are going well. This is a "snapshot" observation each week with timely feedback sent to teachers.
- Formal Observations have begun. The format for these observations is very different from the Walkthroughs. An entire lesson is observed with careful attention to management, planning, instructional presentation, assessment, instructional monitoring, and professional efforts. Feedback is shared at a post conference that takes place within 10 days from the observation.
- Miss McGinnis met with all of our new K-3 PCA hires this month. These meetings served as a personal check-in. A survey was sent prior to the meetings with the following questions:
 - Please list and/or describe things that you believe are going well.
 - What do you like most about working at PCA?
 - What would make your job more satisfying

<u>PEAK</u>

- The PEAK Board met on Sunday, October 8th.
- PEAK voted to fund a musical performance for the K-3 campus on October 20th. The Virginia Repertory Theatre will perform twice on this day for our students. The first performance will be held at 10:30 for kindergarten and 3rd grade. The second performance will be held at 12:30 for 1st and 2nd grades. 4-8 Report to the Board of Directors Presented by Mrs. Laura Beth Richardson October 2023

Curriculum/Academics/Data

- Tutors
 - Our two tutors, Mrs. Hawkins and Mrs. Yates, have been following their new tutor schedule to support 4th, 5th, and 6th grade students.

- They are supporting a variety of students through the use of our most recent data collection in i-Ready.
- The supplies they are using are a combination of LLI material (Leveled Literacy Intervention) and standards-based math intervention bundles.
- EVAAS Data
 - EVAAS has released student projection summaries. Mrs. Brooks, Mrs. Barnes, and I are working to compile this data for teachers and will be meeting with teachers individually. In these data meetings we help teachers set attainable proficiency goals for each of their classes and offer support based on individual teacher needs.
- Check-Ins
 - 4th-8th grade classes will take Check-In 1 on October 18th-20th. Data from this assessment will be shared in the November board report.

Professional Development:

- Teach Like a Champion
 - The Office of Charter Schools in collaboration with the NC ACCESS Program partnered with Teach Like a Champion to provide charter school leaders and teachers the opportunity to engage in Teach Like a Champion training. The NC ACCESS Program sponsored 200 charter school teachers and charter school administrators to participate in the training.
 - Teach Like a Champion provides educators with a set of techniques, a shared vocabulary, and a framework for practice that equip teachers to achieve dramatic results with their students. Their resources are used by schools throughout the world.
 - On Wednesday, September 13th and Thursday, September 14th, I attended the second part of the Teach Like a Champion training in Raleigh (first session was in January of this year).
 - Ms. McGinnis (K-3 Associate Dean), Ms. Cochran (4th grade), Ms. Taylor (2nd grade), and Ms. Collins (Kindergarten) attended as well.
 - Each of us found the training to be extremely beneficial. The teachers have already implemented strategies they learned in January and are eager to implement more moving forward.

Beginning Teacher/New Hires:

- Ms. McGinnis and I sent a survey to our new hires to gain a better understanding of what is going well and what areas they need more support in. We then scheduled individual meetings to dive deeper into their responses.
 - Positives include
 - feeling supported by their fellow teachers and admin team
 - PCA being a positive, professional place to work- school spirit was specifically mentioned
 - Enjoying the content that PCA has to offer in it's curriculum
 - High expectations for students and staff
 - Feeling free to ask questions and getting helpful feedback/advice
 - Areas needing support include
 - Classroom management strategies (resources given in the individual meetings)

- Requests for more knowledge in the EC realm of teaching (ex. how co-teaching works with inclusion teachers, how to better meet the needs of EC students in the classroom, etc.) Ms. Frazier has already reached out and addressed these needs!
- How to help students grow and how to track student growth (resources given in the individual meetings)

4th-8th Grade Activities

- 5th grade students have a field trip planned for Thursday, November 9th to Discovery Place in Charlotte.
- 6th and 7th grade students have a field trip planned for Tuesday, November 21st. They will be going to the Charlotte Motor Speedway for a STEAM program and will take a tour of the UNC Charlotte campus.

Curriculum and Academics:

- Dr. Martin has organized a CFNC day for seniors and their families on Tuesday, October 10th. This session will outline information needed for how to pay for college and steps seniors and families need to take concerning applications and scholarships. There are several big changes to FAFSA this year and this workshop will give our families and students another opportunity to hear about these changes.
- On Wednesday, September 27th Cleveland Community College invited our students to participate in College Experience Day. This was an opportunity for juniors and seniors to visit with the CACRAO college fair or to visit a CTE area of interest. We had many juniors and seniors participate and we are very thankful for this opportunity for them.
- Data from our first Check- Ins are beginning to come in and we are off to a great start. We will continue to push, but pleased with the beginning results.

Mrs. Barnes will meet with grades 4 and 5, Mrs. Richardson with grades 6-8 and I will meet with 9-12 teachers. We will be reviewing EVAAS, EOC results and NC Check In 1.
- North Carolina mandated that all faculty and staff must complete two hours of professional development and mental health training each school year. This professional development is being planned by the counseling department and will take place on the teacher workday, Monday, Oct. 17th.

- Fall pictures will be taken October 3rd and 4th at the 4-12 campus. Mr. Grose will be taking these pictures and they will be included in the yearbook.
- Homecoming
 - The Homecoming parade has been approved by the City of Shelby for Friday, Dec. 1st at 2:00. Preparations for the parade have started.

• Parental Leave Law

- Session Law 2023-14 was enacted by the General Assembly in May 2023, adding G.S. 126-8.6.
 G.S. 126-8.6 provides for paid parental leave for "employees of State agencies, department and institutions, including the University of North Carolina; to public school employees, and to community college employees." G.S. 126-8.6(e).
- The parental leave is available to "public school employees" without exhaustion of the employee's sick and vacation leave and is in addition to other leave authorized by State or federal law.
- Charter schools may opt-in to providing the benefits, and those that do will receive their share of the state funds allocated for substitute teachers.
- PCA currently offers 6-weeks of paid maternity leave. If we "opt-in" for reimbursement of substitute costs, we would offer 8-weeks of parental leave.



5: Coaches Meeting:

At the request of Dr. Shope, I have shared an email correspondence below that outlines a recent meeting on the PCA Coaching Staff and our thoughts on our potential membership in the NCHSAA.

Dear Dr. Shope & Mrs. Brooks,

I hope this email finds you well. I wanted to update you on a recent discussion within the athletic coaching staff here at PCA regarding our potential membership in the North Carolina High School Athletic Association (NCHSAA). The majority of our coaching staff recently convened to deliberate the possibility of joining the NCHSAA for the 24-25 school year.

After careful consideration, the consensus among the coaching staff was that it would be best to postpone our application until the (24-25) school year. The primary reason for this decision is the proposed redistricting of conferences for 1A schools scheduled to occur during the 25-26 school year. By applying next November during the 24-25 school year, we aim to align our membership with the commencement of the completely new redistricting of conferences in 25-26. As the Athletic Director, I endorse the recommendation to defer our application until the 24-25 school year, ensuring that we are well-prepared for full membership within the 25-26 school year, as proposed by our coaching staff. This approach will allow us to dedicate the upcoming 24-25 school year to strengthening our middle school sports programs and enhancing our athletic facilities.

If you have any questions or require further clarification on this matter, please do not hesitate to reach out. Additionally, I'd still like to discuss the possibility of presenting this proposal at an upcoming school board meeting.
