
# **Behavior and Discipline Breakdown for 2024-2025**

- o Grade 3 carried 23%



## • Areas of Celebration

- o 6th grade reading and math scores have increased from 2024.
- Students who have not passed EOGs in previous years passed for the first time this school year. Many of our EC students showed a tremendous amount of growth despite not meeting proficiency.

# • Opportunities for Growth

• While many of our intermediate students have shown a great deal of growth this school year, we are making plans to increase proficiency levels in all intermediate grades and subjects. For example, our 5th grade team will begin team teaching next school year instead of remaining compartmentalized by subject. Plans are also in place to incentivize the use of our research based programs, iReady and Reflex Math.

## **Discipline**

- At the end of the 2023-24 school year, middle school was responsible for 58% of the office referrals for the year. This data was one of the reasons the administrative team used Harry Wong's book, The First Days of School, as a focus this year.
  - At the end of April, middle school was responsible for 38.1% of all referrals at the 4-12 campus- a 19.9 point difference from last year. This data demonstrates the effectiveness of the strategies our teachers used in their classroom!
  - A special thank you to Mrs. Barnes for her work in addressing each of these referrals while building relationships with our students and their families. As always, her goal in addressing behavior is to identify the root cause and set the student up for success moving forward. Final percentages for the year (that will include the month of May) will be shared in the July report.

## **Beginning Teacher/New Hires:**

• A total of 7 teachers exiting the BT program this fall! For the past 3 years they have worked closely with a mentor to gain a clearer understanding of day to day tasks, planning, behavior management, parent communication, curriculum, etc. A special thanks to all of our seasoned teachers who serve as mentors each year. The guidance, support, and encouragement they provide to our beginning teachers has not gone unnoticed.

## Hiring/Personnel

• Congratulations to Mrs. Waldrep on her retirement! Her 30+ years of dedication to educating students is a tremendous accomplishment. We are thankful to have had her as part of the PCA family during her final years in the classroom and wish her all the best on her future endeavors!

## **Extracurricular Activities:**

- 4th, 5th, and Middle School Awards Ceremonies
  - We had a strong finish to the school year that included impressive amounts of parent support and student achievement! The 4-12 gym housed all 4th-8th grade students, families, and staff (at their designated times). Awards included A honor roll, A B

honor roll, highest average, most growth, etc. Special awards such as the Citizenship Award were also presented. Mrs. Dayvault, Mrs. Campbell, and Mrs. Boone spent a great deal of time planning and organizing the middle school awards ceremony. Using our new gym made each ceremony more special!

- Band Results at Solo and Ensemble Festival on Saturday, May 10
  - 4 band students participated in the South-Central District of North Carolina's Music Educator Association's Solo and Ensemble Festival.
    - <u>Hal Irvin</u> 7th grade, first year band student received an **Excellent Rating** for his saxophone solo
    - <u>Stella Navey</u> 8th grade first year band student received an **Excellent Rating** for her clarinet solo.
    - <u>Aerieanna Dyer (10th grade) and Rachael Dodge Jones (11th grade)</u> performed a duet (trumpet and snare drum, respectively) and received a **Superior Rating**.

## **Curriculum and Academics:**

- We had 40 seniors graduate on May 31st, 2025 at Pinnacle Classical Academy's Lyceum. That is 100% of the Class of 2025. consequence, has decided to approve these requests, in bulk, and note the change as an amendment to each charter.

#### ■ § 115C-218.60. Student discipline.

The school is subject to and shall comply with Article 27 of Chapter 155C of the General Statutes, except that a charter school may also exclude a student from the charter school and return that student to another school in the local administrative unit in accordance with the terms of its charter after due processs.


